# TO: All Registered Beverage Manufacturers

#### SUBJECT: Plastic Beverage Container Virgin and Postconsumer Resin Report

Public Resources Code (PRC) Section 14549.3 requires a manufacturer of a beverage sold in a plastic beverage container subject to the California Redemption Value (CRV), to report to the Department of Resources Recycling and Recovery (CalRecycle) the amount in pounds and by resin type of virgin plastic and postconsumer recycled plastic used by the manufacturer for plastic beverage containers subject to CRV for sale in the state in the previous calendar year.

Enclosed is the "Plastic Beverage Container Virgin and Postconsumer Resin Report" (Report) to facilitate providing this information. Do not include confidential information.

#### This information is due to the Department on or before March 1 of each year.
